Many building departments and cities are moving forward to implement more customer friendly projects. Chris Augustin spoke about the City of Fort Lauderdale's effort to review the planning and permitting process and implement a "Lean Permit" program to facilitate and expedite permit applications. Major software and hardware upgrades are talked about to allow instant, simultaneous electronic plan reviews. Pompano Beach is moving into the similar direction and created the P.B. Contractors Forum for March 8.

Other projects promoted by the Greater Fort Lauderdale Chamber and the Greater Fort Lauderdale Alliance are the "Concierge" and "Platinum City" initiatives to encourage businesses to relocate to Broward County.
